Became active in Greenpeace NW.

1985-86: Worked as a paid campaigner on Nuclear Weapons and Waste Project at Hanford, Greenpeace, NW.

1988, June: Began my aerospace career again, hired on at Boeing Aircraft Company, Flightline Avionics, Renton, Seattle and Everett, Pre Flight Aircraft Systems on 737's, 757's, 747-400's and 777 aircraft. I worked in the NW and abroad for 18 years; I was a Steward in IAM-751, Machinists Union. Retired in 2006.

2006-7: Sold our home on 1438 20th Ave, and purchased a Town House at 603 75th Ave. N. and we remain at this address.

2006-2016: Joined the Board of Washington Physicians for Social Responsibility(WPSR) and have been active on Nuclear and Energy Issues. Post-Fukushima, in 2011 a began a special concentration on the only operating nuclear power station in the NW, the Columbia Generating Station (CGS). We've joined Oregon PSR and other activist organizations to begin the shutdown of CGS, and a transformation of our NW electric power needs to renewables.

We also joined Temple Beth Am Synagogue in NE Seattle in 2000 and are active in Health care and working with other religious groups in Seattle.

Undergraduate: Oregon State, Engineering and business at Corvallis, Oregon; Graduating from U of Washington in English in 1963.

Graduate: U of Oregon, Masters, Political Science; U of Indiana, Masters, Urban Economics and Politics.
