I want to thank Councilman O'Brien for the nomination to be a member of the Seattle Park District Oversight Committee. I look forward to the opportunity to serve.

I have been a resident of Seattle since 1973. Since 2010 I have been living in the Green Lake Neighborhood. My two daughters attended and graduated from Seattle schools.

Living in this city I have learned that preserving open spaces, large and small is ever so important. But that is just part of the story. It is how these spaces get used and are managed. Some obviously deserve to be largely left alone to be a natural refuge in the city. Others will be assigned more intense use as neighborhood and community meeting places.

I have been active in goings on around Green Lake and Green Lake Park and volunteer as a Park Steward. CharlieChester (my dog) and I make our nearly daily circumnavigation of the lake. As Charlie and I make our way around the lake I am struck by the diversity of people using the park. And, I am especially struck by the variety of attitudes and opinions about Green Lake as a park and about management of their park.


As a park steward I have helped organize and manage work parties in the park. For the past year I have been part of a small volunteer group organizing ourselves as Green Lake Stewards. We work in partnership with and with support from Green Seattle Partnership and Seattle Park Department staff. Since June of 2015, we have hosted monthly volunteer work parties to work on removing Blackberry and ivy from the lake shore habitat. The next work party is being scheduled for September and we will be receiving a delivery of native plants from Green Seattle Partnership in late October to be installed during an upcoming work party.

It is my great good fortune to live very near to Green Lake Park, this wonderful city resource where I can and do take advantage of its ever changing nature nearly every day. Everyone should be so lucky.

A reality is that there are no neighborhoods and no parks in Seattle that don't deserve and even require more than has been provided. Funding made available through the recently enacted Park District will help improve our wonderful park system to match expectations and promises of what can Seattle Parks can be.

I expect to continue my special interest in Green Lake Park and continue to be an active volunteer in "my" park even as I widen my interest in and awareness of the needs and possibilities throughout the wider park system and city.
