# 1. BILL SUMMARY

- a. Legislation Title: A RESOLUTION relating to the Department of Parks and Recreation; authorizing the Superintendent of Parks and Recreation to submit application(s) for grant funding assistance for Boating Facilities Program project(s) to the Recreation and Conservation Funding Board as provided in chapter 79A.25 RCW, Title 286 WAC, and other applicable authorities, and to enter into project agreements if grant funding is awarded.
- b. **Summary and background of the Legislation**: This proposed legislation authorizes the Department of Parks and Recreation (DPR) to submit grant applications to the State of Washington Recreation and Conservation Office (RCO) Boating Facilities Program (BFP) for state funding assistance. This resolution is required as part of the formal RCO grant application process. Renovations funded by the RCO grant and City match are:
  - <u>Stan Sayres Boat Launch</u>: Renovate the existing fresh water boating facility to provide better utilization and function, replace the existing ramps, extend fixed docks using gangways and floating docks to make the boat launch more accessible.
  - <u>Don Armeni Boat Launch</u>: Renovate the water access at the heavily used salt water boating facility by replacing the old pilings and floating docks with a new floating dock system engineered to withstand site conditions.
  - <u>Leschi Marina South</u>: Construct new breakwaters and remove the existing deficient breakwater / wave attenuation structures. The new amenities will be designed to provide guest moorage tie-up capacity and shoreline access that will increase general public access to the water.

DPR applies for RCO grants each year and has garnered a strong success rate in securing additional funding for planned capital projects. The total funding request will be \$1,000,000 each for three projects (Don Armeni, Stan Sayres and South Leschi).

The RCO grants require a local match, and will fund only projects that are included in an adopted plan (Seattle Parks and Recreation Plan 2000, 2016-2021 Asset Management Plan). The recommended projects meet both criteria. DPR's required matching funds for the Stan Sayres Boat Launch and the Don Armeni Boat Launch are appropriated in the Seattle Parks and Recreation's 2016-2021 Capital Improvement Program. A boat moorage restoration project is included in the 2016-2021 Capital Improvement Program and projects for Leschi Moorage are identified in the 2016-2021 Asset Management Plan.

RCO will announce the grant award recommendations in February 2017, and the actual grant awards will be allocated in June 2017. Project planning and design for Stan Sayres and Don Armeni Boat Launches and the South Leschi Marina began in 2016 with construction planned to start in 2017 after a contract for the grant funding has been fully executed.
