## 1. BILL SUMMARY

**Legislation Title:** AN ORDINANCE relating to a public safety bill of rights for the Seattle public; renumbering Subchapter VI as Subchapter V and creating a new Subchapter VI in Chapter 3.28 of the Seattle Municipal Code.

**Summary and background of the Legislation:** If passed, this legislation would codify the Seattle Police Department's policies protecting the rights of public observers of police activity, and would specify a claims pathway for recovery of equipment and recording damage.

2. CAPITAL IMPROVEMENT PROGRAM
This legislation creates, funds, or amends a CIP Project.
3. SUMMARY OF FINANCIAL IMPLICATIONS
This legislation does not have direct financial implications.

The City has an existing tort claims process under SMC Chapter 5.24. This legislation codifies the value of damaged or destroyed recordings at \$500 and provides an avenue for appeal that can carry a bad-faith penalty against the Chief of Police of \$5,000. It is unknown how many successful claims there might be. It is anticipated that imposition of the penalty would be rare.

## 4. OTHER IMPLICATIONS

a) Does the legislation have indirect or long-term financial impacts to the City of Seattle that are not reflected in the above?

Yes. There may be administrative costs within SPD to respond to claims, plus resources of the Hearing Examiner, SPD, and City Attorney's Office for any appeals.

To the extent that passage of the legislation would have the intended benefits of making observer protections more permanent and create a cause of action as a remedy for the observer, not implementing the legislation would have the impact of failing to achieve those objectives.
