9	WHEREAS, The City of Seattle's 2017 Adopted Budget included a proviso concerning the
10	implementation of recommendations from the North Seattle Human Services Summit that
11	was held on December 6, 2016; and
12	WHEREAS, the proviso in Green Sheet 257-1-B-1-2017 specifies that appropriated funding may
13	not be spent until authorized by future ordinance and that authority will not be granted to
14	spend appropriated funding until the Human Services Department provides Council with
15	a plan for implementing recommendations from the North Seattle Summit; and
16	WHEREAS, the Human Services Department reviewed qualitative data collected from
17	discussions held at the North Seattle Human Services Summit and developed an
18	implementation plan based on the data; and
19	WHEREAS, the Human Services Department has submitted a detailed implementation plan to
20	the Human Services and Public Health Committee on February 8, 2017, in accordance
21	with Green Sheet 257-1-B-1-2017; NOW, THEREFORE,
22	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
