Payment of the sum of \$22,116,619.84 on Summit mechanical warrants 9 numbered 4002789466 – 4002792582 plus manual or cancellation issues for claims, E- Payables 10 11 of \$88,285.27 on Summit 9000027143 – 9000027220 and Electronic Financial Transactions (EFT) in the amount of \$64,916,382.24 are presented for ratification by the City Council per 12 13 Chapter RCW 42.24.180. Section 2. That any act consistent with the authority and prior to the effective date of this 14 15 ordinance is hereby ratified and confirmed. 16
