I was born and raised in Seattle on Capitol Hill, and have also lived in the Rainier Beach and Queen Ann neighborhoods. In 2007, I became a resident of West Seattle where I have lived in the White Center, Highland Park, and Puget Ridge neighborhoods. I went to Stevens Elementary, St. Joseph's, and Roosevelt High School; I then left Seattle to attend Scripps College in Claremont, CA, and lived in Los Angeles for a short time after college. I am of mixed ethnicity and am married to immigrant who has lived in the United States for 10-years, and together we spent 3-years living in Atlanta, GA. Our time in Atlanta, along with our inter-cultural and inter-racial relationship, has had a tremendous impact on my cultural and social perspectives. I have worked in strategic communications, community outreach and public engagement since 2001, and most of my work has been in the public projects arena, but with a focus on increasing equity and engagement in public process and project delivery.

I enjoy and am ignited by build relationships with a diverse people who bring their own unique thoughts and experiences to the table. I see diversity of thought as an asset and tool for finding innovative and fair ways to address growth, public agency service delivery, transportation and housing issues, and human service needs.

I have worked professionally in public affairs, and I was recently finished a contract project for minority owned outreach consulting firm where I researched best practices, history and guiding policies and then developed a model for and social justice engagement that is aligned to Federal, state, county, and city policies, requirements, and goals. I volunteer for many local projects, neighborhood group efforts, and for non-profits focused on serving disadvantaged populations or building community capacity. It is my interest help create fair and valuable outcomes for my community through any and all avenues possible.

Please describe why you are interested in serving on the Community Involvement Commission.

I am very excited about this opportunity because I believe in the need and value of community involvement; and, I have the personal and professional experience and relationships to engage even more people in participation and feedback opportunities that will inform decision that shape Seattle's future.

I understand civic process, public administration, and have extensive experience conducting outreach; I would love to continue growing as a community advocate and liaison and this opportunity would allow me to use my experience and skills to benefit many people who are not currently heard or considered due to a variety of barriers.

When I look at the opportunities on the horizon, such as participatory budgeting, Sound Transit 3 expansion, efforts to increase transportation equity or end homelessness. I feel passionate about ensuring that the diversity of all of Seattle is reflected in the decision making processes, allocation of public funds and resources, and when considering impacts of growth — such as temporary construction impacts and permanent impacts related to increased cost of living. Historically under-represented and under-served populations will likely be disproportionately affected if community advocates do not work to get their concerns heard. I would love to continue my work raising awareness and building connections that can advance important initiatives through collaboration and integration of as many community voices as possible.

I have developed hundreds of contacts and invaluable relationships over a career focused on outreach and engagement. I have worked either personally or professionally with Environmental Coalition of South Seattle, Seattle Urban League, Technology Access Foundation, Tech Diversified, Highland Park Community Club. Delridge Neighborhood Development Association, Habitat for Humanity, Puget Sound Partnership, International Rescue Committee, El Centro de La Raza, Horn of African, Union Gospel Mission, Jewish Federation of Seattle, NeighborCare Health Centers, Central Area Youth Association, and Neighborhood House.

Though my relationships have always been geared towards serving their needs through volunteering or building/facilitating community partnerships to benefit decision-making (rather than informal/casual connections), I have found the friendship and respect remains after the immediate opportunity has passed.
