COUNCIL BILL

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$21,954,561.79 on Summit mechanical warrants numbered 4002822836 – 4002826422 plus manual or cancellation issues for claims, E-Payables of \$98,407.59 on Summit 9000027926 – 9000027995 and Electronic Financial Transactions (EFT) in the amount of \$39,994,096.48 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$44,438,311.70 on City General Salary Fund mechanical warrants numbered 51273632 - 51274373 plus manual warrants, agencies warrants, and direct deposits numbered 210001 – 222559 representing Gross Payrolls for payroll ending date May 16, 2017 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council May 25, 2017 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.
