Johnson Amendment – 2nd Quarter 2017 Supplemental (CB 119022)

This amendment redirects funds within the Transportation Operating Fund to free up \$75,000 of General Fund resources. These General Fund resources would be used to provide contract services (administered by the Human Services Department) for residents of Magnuson Park, and to provide additional security services (administered by the Department of Parks and Recreation) for Magnuson Park. This amendment would reduce SDOT spending on the Summer Streets Program by \$75,000; increase HSD spending by \$63,000; and increase DPR spending by \$12,000.
