a. Legislation Title:

b. AN ORDINANCE granting MCP Alley24 East, LLC, permission to maintain and operate a skybridge over and across the alley in the block bordered by Pontius Avenue North and Yale Avenue North, and John Street and Thomas Street; amending Ordinance 122113, updating the insurance and bond requirements, amending the annual fee and other terms and conditions of the permit, renewing the term of the permit, and providing for the acceptance of the permit and conditions; and ratifying and confirming certain prior acts.

c. Summary and background of the Legislation:

This legislation will allow MCP Alley24 East, LLC to continue maintaining and operating the existing skybridge over and across the alley in the block bordered by Pontius Avenue North and Yale Avenue North and John and Thomas Streets. The skybridge permit is for a period of ten years, commencing on the expiration of the last term on June 21, 2016. The permit may be extended for a successive 10-year term. The legislation specifies the conditions under which permission is granted.

The City originally granted permission for the skybridge by Ordinance 122113 on May 15, 2006. The ratify and confirm clause is required to grant permission for the existing skybridge retroactively to June 21, 2016.
