- Direct the operations of the Office of Police Accountability ("OPA") and supervise a staff of 19 sworn and civilian employees.

Attend the SPD Force Review Board to monitor the Department's internal deliberations on uses of force and to identify conduct that may be inconsistent with policy.
- Collaborate with the Community Police Commission and the OPA Auditor on improving and strengthening Seattle's police accountability system.
- Engage with community members and complainants to address concerns with OPA's processes and to accept comments and criticism regarding OPA's handling of investigations.

Dear Members of the Search Committee:

I write to submit my application to be the Director of the Seattle Office of Police Accountability (OPA). Given my experience, both past and present, I believe that I am uniquely qualified for this position.

Much of the last year of my career was spent working on the landmark legislation that reformed and strengthened Seattle's police accountability system. Not only was I one of the primary drafters of the legislation, but I engaged in hundreds of hours of conversations and meetings about police accountability, what worked and did not work nationally, and, specifically, what the right model was for Seattle. Many of these conversations and meetings were with the members of this search committee. I believe that I have a deep understanding of the goals and purposes of this legislation and I believe that I am the right person to ensure that OPA meets the clear expectations of the City Council, the Mayor's Office, the Community Police Commission (CPC), and the people of this City.

For the last two months, I have served as the Interim Director of OPA. In this role, I have been responsible for the everyday management of OPA including: the coordination between and synthesis of civilian and sworn staff; drafting and submitting budget issue papers; final decisions on case classifications; and referrals of matters for criminal investigations. I have also been the ultimate decision-maker on whether or not to recommend sustained findings to the Chief of Police. I have approached these duties with the gravity, objectivity, and transparency they deserve.

While I believe that OPA has already made substantial strides in the short period that I have been there, I recognize that there is a long way to go. I understand, perhaps better than anyone, the opportunities and challenges that will face the next Director. Even though the accountability legislation has not yet been fully bargained and implemented, I have already begun working to instill its values at OPA. I firmly believe that I am the most qualified candidate to take this task on and to bring the concepts and practices advanced in the legislation to fruition.

To do so, I will rely on my established relationships with the Council, the CPC, the Mayor's Office, the current and former OPA Auditor, the City Attorney's Office, the Seattle Police Department, and the myriad other stakeholders involved in our accountability system. I have built these relationships on trust, hard work, the willingness to listen, and mutual respect. I have endeavored to be a voice of compromise, always trying to bring disparate points of view together and attempting to reach consensus. I have continued to strive to do so as the Interim Director by building on and strengthening my office's relationship with the OPA Auditor and the CPC. I have made our relationships ones of collaboration and understanding, rather than antagonism. I recognize the value in their expertise and experience and firmly believe that the critical analysis of OPA is crucial to the efficient and proper functioning of our system.

I fundamentally believe that OPA's work is not and cannot be simply disciplining officers. Our mission must be broader than that. I believe that to truly systemically reform the Seattle Police Department, OPA must help to build and sustain a culture of accountability throughout the Department. Every Department employee, no matter what rank, must be responsible for policing and supervising in a manner that is equitable, unbiased, compassionate, and consistent with policy, the laws of our City and State, and the United States Constitution. My role as the OPA Director is to ensure that this is the case by conducting thorough, timely and objective investigations, by recommending needed changes to policies and procedures, by working with and listening to the other accountability entities, and by honestly and transparently holding every Department employee to the high standards expected by our community. I believe that I have the vision, credibility, knowledge and determination necessary to succeed in this endeavor.

Thank you for considering me for this position. I hope to have the chance to meet with the search committee to discuss this opportunity further.

Mayor Burgess nominates police accountability director

SEATTLE (October 27, 2017) – Mayor Tim Burgess announced the nomination of Andrew Myerberg as the director of the Office of Police Accountability (OPA) today. Myerberg, a civilian, will lead the OPA, an independent office responsible for investigating complaints of police misconduct and initiating its own misconduct investigations. The nomination is the first made under the <u>police accountability legislation</u> adopted by the City Council in May 2017.

"Meaningful civilian oversight is essential to maintaining the Seattle Police Department as a model for 21st century policing," said Mayor Burgess. "Myerberg is experienced, committed to the public good, and has already begun to build a relationship of trust between our police service and people of Seattle. Myerberg's appointment will continue the vital work of strengthening our city's police accountability systems."

Andrew Myerberg has been serving as director of the fully independent Office of Police Accountability on an interim basis since July 2017. Prior to this appointment, Myerberg was a team leader of the Police Action Team within the Seattle City Attorney's Office and lead counsel in <u>United States v. City of Seattle</u>, the court case that resulted in the city signing the Consent Decree that established federal oversight of the Seattle Police Department. He also acted as the primary contact for the City's legislative, executive, and judicial departments and agencies on all matters related to criminal law, police operations and reform, and civil rights. Prior to joining the City Attorney's Office, Myerberg spent six years working for the New York City Law Department, representing government officials and the City of New York in over seventy federal actions.

"Our new police accountability system relies, in part, on an OPA civilian director that will prioritize quality of investigations and collaboration with the Office of Inspector General, the Community Police Commission, and the public at-large," said Councilmember M. Lorena González. "I believe that Andrew Myerberg holds these values and will stand up in the face of police misconduct, while providing procedural justice for officers and the public. Myerberg's nomination is another meaningful step toward ensuring long-term,

sustainable police accountability and reform. Over the next several weeks, I will lead Myerberg's nomination through the Council confirmation process and look forward to supporting his nomination."

Isaac Ruiz, Community Police Commission (CPC) Co-Chair stated, "During his time in the City Attorney's Office, Andrew served for a time as the lawyer advising the Community Police Commission. We found him to be committed to reform of policing, and also, comfortable with elevating the voices of community leaders and honoring community expertise. These are essential qualities at OPA. Since he took over as interim OPA Director, we've seen improved practices and a dedication to transforming that agency, as well as improved morale. SPD employees have also expressed confidence in Andrew's fairness. The CPC looks forward to partnering with Andrew to strengthen community oversight of policing in the years ahead."

"I am honored to be nominated for this role and look forward to continuing my work strengthening the Office of Police Accountability," said Andrew Myerberg. "This work is not just about disciplining officers when necessary. It is about building and sustaining a culture of accountability throughout the Seattle Police Department. I brought this firm belief to my role as interim OPA director, and I promise to hold fast to it as director."

The nominee for the OPA director was selected through a competitive process which began in July 2017, when City officials announced the selection process for the OPA director and the inspector general for public safety. A search committee with representatives from the Office of the Mayor, City Council, the Community Police Commission and the Seattle Police Department, recommended Myerberg to Mayor Burgess for appointment. The committee received 145 applications and interviewed four finalists before agreeing that Myerberg was the best and most qualified candidate.

The accountability reform <u>legislation</u> is the product of months-long discussions with the Community Police Commission, Federal Monitor Merrick Bobb, City Council and the Mayor's Office. It reflects the City's commitment to working with the federal court to bring the City into compliance with the Consent Decree.

This nomination announced today is subject to confirmation by the Seattle City Council. The Council's Gender Equity, Safe Communities and New Americans Committee is expected to consider the nomination in November 2017.
