### **1. BILL SUMMARY**

- a. **Legislation Title:** AN ORDINANCE relating to land use and zoning; amending Sections 23.42.106 and 23.42.118 of the Seattle Municipal Code (SMC); to modify standardsfor the expansion of nonconforming uses and structures.
- b. **Summary and background of the Legislation:** The amendments to the Land Use Code (Title 23 SMC) would allow the Seattle Asian Art Museum (SAAM), a non-conforming landmark structure and use located in Volunteer Park, to expand subject to new development standards to help ensure compatibility with the park.

The proposed amendments would only apply to the SAAM building in Volunteer Park. The building is an established non-conforming structure and use. The proposed bill would allow the museum to expand subject to new development standards including a limit on the size of future addition(s).

The SAAM project involves the renovation of the existing building and two additions to the existing structure. A Director's decision on the Master Use Permit for this project was issued on March 16, 2017. SDCI may not issue the permit until a Certificate of Approval to modify the building and park, both designated City landmarks, is granted by the Landmarks Board, and land use code amendments allowing the expansion are adopted by City Council. A related proposal by the Seattle Parks Department will address the amended lease and a development agreement between Parks and SAAM.

The proposed amendments would allow the expansion of a City-owned building on a Cityowned property. SDCI does not anticipate any direct financial impacts to the department related to the adoption of the amendments to the Land Use Code. Seattle Parks and Recreation is currently in the process of developing an amended lease and a development agreement for the property. Any financial impacts resulting from the expansion could be addressed as part of the lease and agreement.

### c. Is there financial cost or other impacts of *not* implementing the legislation?

SAAM has indicated that renovation, and associated expansion, are necessary to continue to operate in the Volunteer Park building in the long-term. The code amendments are necessary to allow the expansion. If the code amendments are not adopted, SAAM would be less likely to remain a tenant at Volunteer Park in the long-term.

This legislation would apply to the Seattle Asian Art Museum building located in Volunteer Park. A map of the affected property is attached.

This legislation is not anticipated to negatively impact vulnerable or historically disadvantaged communities. The proposal would allow the expansion of the building, which would allow SAAM to expand the Asian art and cultural and educational services that they provide.
