Relevant Work Experience

City of Tukwila, Urban Environmentalist, 2005 - 2014

Served as Tukwila's biologist responsible for critical areas management, urban forestry issues, and shoreline ecosystem management. Responsibilities included:

- Implementation of Sensitive Areas Ordinance protecting wetlands, watercourses, steep slopes and other critical areas, reviewed mitigation plans, monitored implementation of mitigation, reviewed monitoring reports.
- Enforcement of Tree Ordinance (permits for tree clearing, requirements for tree replacement).
- Development of an urban forestry chapter as part of an update to the Tukwila Comprehensive Plan, which included objectives, goals, and specific policies to increase urban tree canopy and protect existing trees. Coordinated grant-funded urban forest canopy study. Staffed volunteer urban forestry advisory committee. Defended the new chapter before Planning Commission and City Council. Designed and coordinated grant-funded training program for City maintenance personnel regarding tree pruning and recognizing hazardous trees.
- o Implementation of Shoreline Master Program for issues related to shoreline habitat mitigation, restoration of shoreline vegetation, contaminated sites and salmon enhancement projects. Wrote sections of proposed SMP update relating to tree and vegetation protection and shoreline habitat restoration. Developed new standards for re-vegetation of buffer areas and mitigation of unavoidable impacts.
- Represented City on the WRIA 9 Duwamish River Blueprint update for the salmon transition zone.
- Reviewed SEPA checklists and environmental impact studies related to the natural environment.
- Coordinated with other regulatory agencies (Washington Department of Fish and Wildlife, Department of Ecology, Corps of Engineers, National Marine Fisheries Service, Washington Department of Natural Resources, etc.).

Environmental Restoration/Mitigation Project Examples:

- Designed wetland buffer enhancement project for the east side of 19 acre Tukwila Pond; recruited and lead volunteers and other city department staff in implementation; obtained grants for soil enhancements, fencing and plants; managed budget, contracts and monitoring/reporting.
- o Prepared restoration plan for very disturbed seasonal urban creek next to City Hall. Led removal of invasive plants (volunteer and contracted crews), installation of large woody debris, and planting and installed irrigation. Oversaw maintenance activities for 3 years.
- o In collaboration with BECU and Forterra supported restoration of Duwamish River Shoreline for the Restore the Duwamish Shoreline Program. Obtained City and grant funding. Prepared planting plans, ordered plants and supplies, worked with volunteers, and oversaw monitoring and maintenance.
- o Developed planting plan for shoreline restoration on Duwamish River (Codiga Park) for implementation by volunteers from local environmental organization.
- Developed planting plan for restoration of riparian area along section of Southgate Creek (carried out by Public Works and Parks Departments).
- o Reviewed design and oversaw implementation of Tukwila Pond wetland mitigation project on a 4 acre emergent wetland vegetated with Reed Canarygrass. Reviewed & approved planting plan, wildlife features, grading plan, soil amendment plans, and proposed monitoring program. Reviewed monitoring reports, maintenance activities and conducted site visits.
- Developed off-site wetland mitigation program using City-owned properties in Tukwila for prioritizing mitigation sites where site conditions favor wetland enhancement or creation and long term maintenance. Approved by City Council.
- Reviewed and commented on proposed mitigation plans for watercourse restoration, wetland enhancement and wetland creation, including proposed planting plans for a proposed 400-acre development in South Tukwila involving nearly 20 acres of wetland, stream and shoreline mitigation.
- Supervised final plantings and maintenance and monitoring for wetland, watercourse and buffer mitigation by Sound Transit related to the installation of Link Light Rail.

- Provision of technical assistance and training in environmental enforcement, preparation of environmental regulations, and environmental compliance inspections to national and local government regulatory personnel in developing countries.
- Assessment of potential environmental and social impacts of proposed projects and programs (infrastructure, agriculture, environmental management, technology development, tourism) in developing countries. Identification of mitigation measures to reduce impacts, improve sustainability. Preparation of environmental and social management plans including: institutional strengthening requirements and designation of responsibilities; required mitigation and timing; monitoring and reporting plans; and budgets for implementation.
