### BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 1 of Ordinance 124904 is hereby amended as follows:

Section 1. A loan of up to \$26,300,000 of principal and interest outstanding at any one time is hereby authorized to be made from the ((City's Consolidated (Residual) Cash

Pool, or its participating funds,)) Revenue Stabilization Fund to the Transportation ((Master)) Fund from which may be paid capital costs related to the Mercer West project and related debt service costs. This loan is to be repaid no later than ((December 31, 2017)) December 31, 2019, with interest on the loan at the rate of return of the City's Consolidated (Residual) Cash Pool.

Section 2. Section 3 of Ordinance 124904 is hereby amended as follows:

Section 3. The Director of Finance may effectuate the loan authorized in Section 1 by transferring cash from ((one or more of the funds participating in the City's Consolidated (Residual) Cash Pool)) the Revenue Stabilization Fund to the Transportation ((Master)) Fund, or by carrying the Transportation ((Master)) Fund in a negative cash position in an amount not to exceed \$26,300,000 ((beyond the negative balance authorized by Ordinance 120016,)) until no later than ((December 31, 2017))

December 31, 2019.
