COUNCIL BILL

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$25,812,905.26 on Summit mechanical warrants numbered 4002893210 - 4002896161 plus manual or cancellation issues for claims, E-Payables of \$160,581.66 on Summit 9000029825 – 9000029904 and Electronic Financial Transactions (EFT) in the amount of \$28,148,088.26 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$45,208,142.45 on City General Salary Fund mechanical warrants numbered 51285938 - 51286591 plus manual warrants, agencies warrants, and direct deposits numbered 470001-482722 representing Gross Payrolls for payroll ending date November 14, 2017 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council November 21, 2017 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

Section 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.
