COUNCIL BILL 1/9181

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$7,595,071.48 on PeopleSoft 9.2 mechanical warrants numbered 4100000242 - 4100001161 plus manual or cancellation issues for claims, E-Payables of \$79,492.78 on PeopleSoft 9.2 9100000001 – 9100000027 and Electronic Financial Transactions (EFT) in the amount of \$27,291,490.74 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$45,397,841.64 on City General Salary Fund mechanical warrants numbered 51288619 - 51289187 plus manual warrants, agencies warrants, and direct deposits numbered 30001-42650 representing Gross Payrolls for payroll ending date January 9, 2018 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council January 18, 2018 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.
