Ahmed was born in Somalia, and currently lives in Renton with his wife and children. In 2015, he took part in a medical mission in Somalia, rebuilding and supplying two rural hospitals in Somalia, ravaged by years of civil conflict. He serves on several boards, including the King County Accountable Communities of Health (ACH), King County Immigrant/Refugee Task Force to investigate the creation of immigrant and refugee commission and the Fred Hutchison's Health Disparities Community Advisory Board.									
Ahmed also takes pride in serving as a mentor for the youth, with emphasis on careers in the health industry. Currently, in his day to day pharmacy work and Somali Health Board's, he oversees many students who seek his advice, mentorship, and reference that are interested in pursuing careers in the health fields. He sees the youth's direct involvement with community work as a cornerstone to a greater community.
