12	WHEREAS, to construct, operate and maintain hydrants, water mains, domestic meter vaults,
13	fire service meters and appurtenances located on private property for water utility
14	purposes, the City requires easements from private property owners; and
15	WHEREAS, certain private property owners have developed and improved their property and
16	have granted easements to the City as a condition of the installation of necessary water
17	facilities; NOW, THEREFORE,
18	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
19	Section 1. The City of Seattle hereby accepts the easements granted to the City of Seattle
20	for water utility purposes over, under, across, and upon the real property generally described
21	below and legally described in Attachment 1 attached to this ordinance.
22	Grantor: Shorewood Apartment, LLC, grants and conveys to the City an easement for
23	hydrant and appurtenances in the vicinity of 16 th Avenue South and Southwest 112 th Street, King
24	County, Washington, as recorded under King County Recording No. 20050602000093; and
25	Grantors: Venny Van, as a separate estate, and Phong Le, as a separate estate, grant and
26	convey to the City an easement for hydrant and appurtenances in the vicinity of Renton Avenue
27	South and 54 th Avenue South, Seattle, Washington, as recorded under King County Recording

No. 20160310000828.

Grantor: JC Maybeck LLC, a Washington Limited Liability Company, grants and conveys to the City an easement for water main and appurtenances in the vicinity of Southwest Spokane Street and Fauntleroy Avenue Southwest, Seattle, Washington, as recorded under King County Recording No. 20160811000352.

Grantors: MHNW 10 Othello West LP and MHNW 9 Othello East LP grant and convey to the City an easement for domestic meter vault, a fire service meter and appurtenances in the vicinity of Martin Luther King Jr Way South and South Myrtle Street, Seattle, Washington, as recorded under King County Recording No. 20161107000327.

Section 2. The real property rights and interests conveyed by the easements referenced and accepted in this ordinance shall be placed under the jurisdiction of Seattle Public Utilities.

Section 3. Any act consistent with the authority of this ordinance taken prior to its effective date is ratified and confirmed.
