CITY OF SEATTLE 1 2 ORDINANCE COUNCIL BILL 3 4 5 AN ORDINANCE approving and confirming the plat of "Madrona Glen" in portions of the 6 Southeast 1/2, Southwest 1/4, of Section 25, Township 24 North, Range 03 East, W.M. in King County, Washington. 7 8 9 WHEREAS, a proposed plat of "Madrona Glen" has been submitted for approval to the Seattle 10 Department of Construction and Inspections (SDCI) and given the Permit No. 3018840; 11 and 12 WHEREAS, following review and recommendations by the various City departments that have jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of 13 14 Seattle, the Hearing Examiner approved the preliminary plat of "Madrona Glen" subject 15 to certain conditions on June 29, 2016; and 16 WHEREAS, the Director of Transportation and the Director of SDCI have, subject to Council 17 approval, approved the final plat and have reported that the final plat now meets all of the 18 requirements of the state platting law (chapter 58.17 RCW) and of the Seattle Municipal 19 Code (chapter 23.22), except for the execution of the required certifications by the King 20 County Assessor and the King County Finance Division; and 21 WHEREAS, the Director of Transportation and the Director of SDCI report that the plat of "Madrona Glen," a copy of which is in Clerk File 314274, is now complete and ready for 22 23 City Council approval; NOW, THEREFORE,

25	Section 2. With respect to the plat of "Madrona Glen," together with any interest in					
26	abutting streets, as executed by Robert Hardy as Managing Member and approved by the					
27	Director of Transportation and the Director of the Seattle Department of Construction and					
28	Inspections, the following findings are hereby made:					
29	(a) The final plat is in substantial conformance with the approved preliminary plat;

- (b) When both the King County Assessor and King County Finance Division have affixed their certifications as required by RCW 58.17.160(4), the requirements of State law and City ordinances that were in effect at the time of preliminary plat approval will also have been satisfied by the subdivider; and
- (c) The public use and interest will be served by the establishment of the plat, and the plat makes appropriate provision for the public health, safety, and general welfare.
- Section 3. The plat of "Madrona Glen," a subdivision in portions of the Southeast 1/2, Southwest 1/4 of Section 25, Township 24 North, Range 03 East, W.M. in King County, Washington, is in all respects approved and the plat confirmed and accepted, subject to certification by the King County Assessor and King County Finance Division, and the City Clerk is hereby authorized and directed to execute a certificate upon the face of such plat attesting to the approval thereof as evidenced by enactment of this ordinance.

2	the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it						
3	shall take effect as provided by Seattle Municipal Code Section 1.04.020.
