Payment of the sum of \$19,794,694.29 on PeopleSoft 9.2 mechanical warrants 10 numbered 4100046527- 4100049159 plus manual or cancellation issues for claims, E- Payables 11 of \$71,426.61 on PeopleSoft 9.2 9100000635 - 9100000696 and Electronic Financial 12 Transactions (EFT) in the amount of \$15,791,588.55 are presented for ratification by the City 13 Council per Chapter RCW 42.24.180. 14 Section 2.
