1. **Legislation Title:** A RESOLUTION relating to the City Light Department; adopting a 2019-2024 Strategic Plan for the City Light Department and endorsing a six-year rate path required to support the Strategic Plan.

# 2. Summary and background of the Legislation:

This resolution adopts City Light's 2019-2024 Strategic Plan. It also endorses the rate path required to support the strategic plan, which averages 4.5% per year, and requests that the Department prepare the 2019-2020 proposed budget and rates to reflect a 5.8% rate increase in 2019 and a 5.4% rate increase in 2020.
