1. BILL SUMMARY

- 1. **Legislation Title:** An ordinance relating to noise control; establishing an alternative enforcement 75-foot standard for determining excessive vehicle noise and amending Chapter 25.08 of the Seattle Municipal Code.
- 2. **Summary and background of the Legislation:** Historically, the City of Seattle has experienced ongoing issues with select vehicle noise. Vehicle noise issues, particularly from mufflers, have been geographically driven and focused primarily on Alki with some additional areas Downtown. The Seattle Police Department (SPD) has indicated that it has worked to address these issues. However, SPD has also indicated that existing ordinances, technology, and operational prioritization have combined to make effective enforcement difficult.

One of the SPD's central concerns in this area has focused on the use of noise meters, which are required to enforce the excessive noise provisions of SMC 25.08.430. SPD staff have indicated that the Department does not possess noise meters, that noise meters are very difficult to use and that the calibration requirements are difficult to teach and operationalize.

The Department has indicated that enforcement of SMC 25.08.430 would be easier if the provision included a rule that allowed officers to enforce excessive vehicle exhaust noise without noise meters. The Council Bill amends current code to allow enforcement when vehicle exhaust noises (e.g. mufflers) "can be clearly heard by a person of normal hearing at a distance of 75 feet or more from the vehicle itself."
