1. BILL SUMMARY

- 1. Legislation Title: AN ORDINANCE relating to the Municipal Art Fund; amending Section 20.32.030 of the Seattle Municipal Code to remove the timing limitation on the use of funding.
- 2. Summary and background of the Legislation: The Municipal Art Fund (MAF), established as the public art fund for the City, is primarily funded by contributions from the 1% for Art capital program and supports public art installations across the City. The current SMC contains a provision that places a three-year time limit on 1% contributions from other funds with an extension provision for up to five years. After expiration, funds are returned either to the General Fund if an unrestricted resource or the originating fund if a restricted resource (utility, bond, etc.) The purpose of this expiration was to encourage the provision of public art in a timely manner. However, reprioritization of funding to avoid expiration has caused unnecessary administrative work for ARTS and continuously extending funds due to project and program delays causes unnecessary work for departments as well.

Due to the funds expiration timeline, ARTS often develops projects that have larger commission amounts to ensure that the funds can be expended within the SMC window. Qualification for these larger projects requires substantial experience and typically they are awarded to established artists who may be unrepresentative of communities of color or other underrepresented communities in Seattle. ARTS would like to have the flexibility to have smaller projects over a longer period, to explore programs that allow entry into the public art field from those traditionally excluded from the process. ARTS believes this approach will encourage artists of color and emerging artists from other communities to participate more in public art commissions and help these artists build experience and a portfolio for larger awards.
