1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to City employment, commonly referred to as the Second Quarter 2018 Employment Ordinance; designating positions as exempt from Civil Service status; and establishing new titles and salaries; all by a 2/3 vote of the City Council.

Summary and background of the Legislation: This legislation seeks to designate five positions as exempt from Civil Service status and establish new titles and salaries. If passed, this legislation:

- 1. Establishes five positions as exempt from Civil Service status. The nature of the work to be performed by the positions is consistent with the exemption criteria set forth in Seattle Municipal Code Section 4.13.010 and Personnel Rule 2.2. This position change may create a cost increase for the affected department, which will be funded within the existing budget authority.
- 2. Establishes new titles of Paralegal Law and Paralegal, Senior Law and corresponding rates of pay.
