1. BILL SUMMARY

1. Legislation Title:

A RESOLUTION related to the Move Seattle Levy; establishing principles for developing a revised workplan for Move Seattle Levy projects to ensure transparency, accountability, and thoughtful community outreach.

2. Summary and background of the Legislation:

In 2015, Seattle voters approved a nine-year, \$930 million Move Seattle Levy to fund transportation infrastructure improvements. The levy committed to investments in Safe Route Programs, Congestion Relief Programs, and Maintenance and Repair Programs; and provided an illustrative Spending Breakdown of the anticipated project deliverables.

In 2018, SDOT began a comprehensive assessment of the Move Seattle program and determined that with current funding levels, current cost estimates, and current accounting practices, the department was unable to deliver the full scope of the Move Seattle projects as described in the Spending Breakdown. SDOT continues to work with the Levy Oversight Committee and modal advisory boards to consider revisions to planned levy spending.

This legislation establishes guiding principles for SDOT's work in developing a revised workplan for Move Seattle projects, to focus on transparency and building public trust. The legislation requests a final report documenting the revised workplan, and changes from the original Spending Breakdown, by December 1, 2018.
