1 CITY OF SEATTLE ORDINANCE 125646 2 COUNCIL BILL 119322 3 4 5 AN ORDINANCE relating to the Department of Parks and Recreation; authorizing the acquisition of real property commonly known as 7137 38th Avenue Southwest; 6 authorizing acceptance and recording of the deed for open space, park, and recreation 7 8 purposes; and ratifying and confirming certain prior acts. 9 10 WHEREAS, the City Council passed Ordinance 124468 in 2014, authorizing an interlocal 11 agreement between the City of Seattle and the Seattle Park District, which included the 12 Seattle Park District Financial Plan: 2015-2020; and 13 WHEREAS, the Seattle Park District Financial Plan: 2015-2020 includes the Park Land 14 Acquisition and Leverage Fund, which is to be used to acquire park lands, including 15 acquisition of properties to fill gaps in existing public ownership and preserve continuity 16 within the city's greenspaces; and WHEREAS, the Department of Parks and Recreation has determined that the Orchard Street 17 18 Ravine provides significant open space benefits, including wildlife habitat and 19 recreational opportunities, and the area is, therefore, a priority area for additional 20 acquisitions for parks and open space; and 21 WHEREAS, funding for the acquisition is available from the Park Land Acquisition and 22 Leverage Fund and has been appropriated by Ordinance 124927; NOW, THEREFORE, 23 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 24 Section 1. The Superintendent of Parks and Recreation ("Superintendent"), or the 25 Superintendent's designee, is authorized, on behalf of The City of Seattle, to acquire the 26 following described real property, situated in the City of Seattle, County of King, State of Washington, and commonly known as the property at 7137 38th Avenue Southwest 27

13	recreation purposes by attaching to the deed the Superintendent's written acceptance thereof, and
14	recording the same.
15	Section 3. The Property shall be placed under the jurisdiction of the Department of Parks
16	and Recreation.
17	Section 4. Any act consistent with the authority of this ordinance taken after its passage
18	and prior to its effective date is ratified and confirmed.

1	Section 5. This ordinance shall take effect and be in force 30 days after its approval by
2	the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
3	shall take effect as provided by Seattle Municipal Code Section 1.04.020.
