Budget Action description:

This green sheet would add \$50,000 GF in 2019 and \$50,000 GF in 2020 to Seattle Public Utilities (SPU) to expand the Sharps Collection program.

The Sharps Collection program provides safe disposal of "sharps" (syringes, needles, and lancets) by removing them from public property within 24 hours, installing and servicing disposal boxes, and educating community groups and the public about safe handling and disposal of sharps. The program currently operates six large collection boxes in the public right-of-way and in City parks, and three smaller collection boxes in park restrooms. Three additional large boxes will also be deployed by the end of 2018 or early 2019.

The proposed budgets would provide \$428,000 in 2019 and \$443,000 in 2020 for the program. This green sheet would allow for an expansion of the program, potentially through partnerships with businesses in communities heavily affected by intravenous drug use. If SPU were to expand the program using its current model, the additional funds could cover the installation and servicing costs for approximately 4-5 large boxes or 13-14 small boxes.
