COUNCIL BILL 193

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

#### BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$22,998,551.62 on PeopleSoft 9.2 mechanical warrants numbered 4100118019 – 4100120560 plus manual or cancellation issues for claims, E-Payables of \$61,617.47 on PeopleSoft 9.2 9100001825 – 9100001873 and Electronic Financial Transactions (EFT) in the amount of \$34,469,365.46 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$47,095,158.22 on City General Salary Fund mechanical warrants numbered 51304394 – 51305099 plus manual warrants, agencies warrants, and direct deposits numbered 430001 – 432737 representing Gross Payrolls for payroll ending date October 16, 2018 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council October 25, 2018 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

Section 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.
