Dear Maha Jahshan,

Working directly with families struggling to make ends meet reinforced my understanding that my own personal experiences growing up were not anomalies, but part of the challenges that families face nationwide. Barriers to employment, housing, and education can be even pronounced for immigrants and refugees. Individuals and families do not live single-issue lives and understanding the compounding effects of interrelated issues is crucial to addressing their full needs.

As a graduate student in the Evans School of Public Policy & Governance, I bring these experiences to classroom conversations and projects. In my time as a student here, I have chosen to explore through my coursework housing conditions of American Indian & Alaska Native populations, a proposal to have an entirely online community college, and what the consequences for immigrant communities in California are of adding a citizenship question to the 2020 Census.

In my position as a Community Support for Families Worker I connected families with community resources. After the election of the new administration, several of the undocumented families I was working with began to express more fear and stress about the uncertainty of their status in this country, and what would happen to their families if they got deported. I gathered and compiled resources for our undocumented families and trained fellow staff on how to effectively use these resources with families.

As a passionate and dedicated advocate for immigrant communities, my goals align well with those of Seattle Immigrant and Refugee Commission. My strong organizational skills, positive attitude, and experience with the challenges that families face will allow me to make a positive impact while growing personally and professionally in this commission. I welcome the opportunity for an interview to discuss my qualifications in person. Thank you for your consideration and I look forward to hearing from you soon.
