1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to fees charged by the Seattle Animal Shelter; and amending Chapter 9.26 of the Seattle Municipal Code to make technical corrections.

Summary and background of the Legislation: This legislation is a technical correction to CB 119385. The legislation rounds up the cat license fee (consistent with FAS practice when such fees are adjusted), removes a confusing rounding requirement for the senior discount program and updates the potbelly pig license late fee to be the same as dog, cat and goat license late fees.

FAS's revenue assumptions for 2019 assumed the rounding up of these fees and consistency across all license late fees. This legislation more exactly aligns those revenue assumptions with the language in the fee ordinance.

Is there financial cost or other impacts of *not* implementing the legislation?

Because many individuals who receive the senior discount mail in their payment, FAS estimates that if the legislation is not implemented, 500 payments per year will be short by \$0.50. Staff is required to manually adjust all these payments. If the legislation is not implemented, there will also be an \$11,000 undercollection in altered cat license fees.
