1. BILL SUMMARY

1. **Legislation Title:** AN ORDINANCE relating to The City of Seattle’s datum point; updating the vertical and horizontal reference datum for City of Seattle departments and outside entities as a standard elevation reference plane; requiring certain measurements for preliminary plats to be based on the updated vertical and horizontal datum; amending Chapter 1.20 of the Seattle Municipal Code; and amending Sections 23.22.020, 23.75.100, 25.06.030, 25.06.070, and 25.06.090 of the Seattle Municipal Code.

2. **Summary and background of the Legislation:** A datum point is a reference point used in surveying and construction to provide a known location for measuring the position or height of an object in relation to the datum point. Seattle’s original local vertical datum was established, in 1883. The City in 2003 adopted the current official horizontal and vertical datums which are defined as The North American Datum of 1983 and The North American Vertical Datum of 1988. The datums comprise a series of stable, monumented points and reference stations, established and maintained by the United States National Geodetic Survey (NGS). The NGS continually monitors its datum reference station and adjusts it over time, the most recent of which occurring in 2011. In the interest of public safety, health and welfare the City’s utility, transportation and other assets have a common vertical and horizontal reference system. This proposed legislation would amend the Seattle Municipal Code to bring the City’s Horizontal and Vertical Datums into alignment with current and future NGS datums by putting forth language that defines the official City of Seattle datums as the most current NGS datums. This would eliminate the need for future code updates each time the NGS adjusts its datums.
