Weekly Overview

We have officially reached the halfway point in the 2019 legislative session! Both chambers were mostly on the floor last week debating and voting on bills that are in their house of origin. They were on the floor late into the night on most days and both chambers were on the floor on Saturday as well. All bills must pass off the floor of the chamber in which they were originally introduced by March 13th or they will be considered dead. This means House bills have to pass off the House floor and Senate bills off the Senate floor. Bills that pass off the floor in their house of origin will then flip sides and go through the same process they've been through in their house of origin. After Wednesday's house of origin cutoff, hearings will resume again as policy committees consider bills that have been sent over from the opposite house.

At this point <u>almost 2,300 bills</u> have been introduced this session, but only 1,010 made it past the house of origin fiscal cutoff on March 1st. You can see a list of bills that past fiscal cutoff <u>here</u>.
