Subject: 2019 Adopted Budget Update

The Executive has proposed Council Bill 119479, which would update the 2019-2020 budget to reflect the adopted 2019-2020 4th Quarter Supplemental Budget adopted by Ordinance 125739. The proposed ordinance includes:

- Attachment A: CIP Project Allocation Adjustments to the adopted 2019 Budget, reflecting the 2018 fourth quarter supplemental changes.
- Attachment B: CIP Project Page Substitutes to replace pages included in the adopted 2019-2024 Adopted CIP with those from the 2018 fourth quarter supplemental changes.
- <u>Attachment C: New CIP Projects</u> added to the 2019-2024 Adopted CIP from the 2018 fourth quarter supplemental budget.
