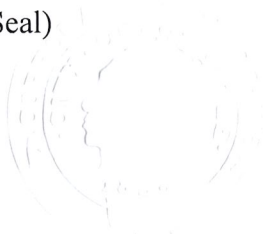

Monitor implementation of Cultural Districts, including the Arts & Cultural District for Columbia City/Hillman City; consider proposals for the creation of new art districts; consider affordability for cultural commercial spaces; and review potentially forthcoming legislation.

CREATION, ACTIVATION AND PRESERVATION (CAP) OF CULTURAL SPACE

Monitor implementation of "The CAP Report: 30 Ideas for the Creation, Activation, and Preservation of Cultural Space;" particularly creation of a cultural space management public development authority.

FUNDING FOR CAPITAL FACILITIES

Monitor new capital facilities fund grants for non-City owned arts and cultural facilities, and consider potential amendments to program provisions.

Monitor the Office of Arts and Culture's budget and review arts-related legislation as necessary.

TOWN HALL

Help develop and review the public benefits agreement between the City and Town Hall in legislation to lift the proviso in Green Sheet (GS) 2-5-B-1-2019, which provides funding to Town Hall for its renovation.

CIVIL RIGHTS

BAIL REFORM

Monitor and participate in a Seattle Office for Civil Rights (SOCR)-led work group preparing responses to Statement of Legislative Intent (SLI) 303-1-A-2-2018, exploring reform of bail practices and pre-trial release strategies with a racial equity lens.

BIAS CRIME AUDIT

Review Phase 2 of the City Auditor's "Review of Hate Crime Prevention, Response and Reporting in Seattle"; and co-convene a public meeting with the Department of Justice Community Relations Services (CRS) regarding a regional approach to responding to hate crimes. Consider legislation to amend SMC to improve City response to hate crimes.

CAREGIVER ADMISSIONS

Research and develop legislation to provide for free admission to caregivers of people with disabilities to arts and cultural venues in the City.

CIVIL LEGAL AID

Monitor funding and implementation of direct representation of King County Department of Public Defense's criminal defense clients in civil proceedings, particularly with respect to housing matters.

COMMUNITY RESIDENT PREFERENCE PROGRAMS

In collaboration with the Housing, Health, Energy and Workers' Rights Committee, review SOCR and OH recommendation resulting from Council Resolution 31754, regarding community resident preference programs to address gentrification and displacement that will be reflected in proposed changes to the Housing Levy Administrative and Financial Policies and City Housing Funding Policies slated for consideration and adoption this year.

EMPLOYMENT AND HOUSING BIAS

Monitor employment bias and fair housing testing results, community education, and outreach.

EVICTION

Develop legislation in response to the Seattle Women's Commission report "Losing Home" to ease impacts of eviction on tenants, particularly in marginalized communities, including reviewing the response to SLI 33-5-A-2-2019 addressing how to resolve habitability issues in rental units on a faster timeline.

EXISTING PROTECTIONS

Monitor the implementation of the first-in-time and alternative source of income ordinances.

HOMELESSNESS SERVICES FOR LGBTQ COMMUNITY

Review new guidelines for homelessness service contracts ensuring adequate services to the LGBTQ community pursuant to SLI 15-17-A-2-2019. Guidelines should be accompanied by a report and timeline for their implementation.

HOTEL WORKER PROTECTIONS

Pursue legislation to provide health and safety protections to hotel employees, similar to the protections intended by Initiative 124 that was approved by voters in 2016.

NAVIGATION TEAM

Monitor Navigation Team performance. Track and assess Human Services Department reporting on the Navigation Team as described in the Office of the City Auditor's "Reporting Plan for Navigation Team" and as outlined in GS 14-95-A-4-2019.

OPEN CAPTIONING

Work with the Commission for People with Disabilities to develop legislation to strengthen captioning requirements on televisions in places of public accommodation.

RACE AND SOCIAL JUSTICE INITIATIVE (RSJI)

Develop training for the legislative department with the RSJI change team. Apply the racial equity toolkit to legislative department policies, specifically to the public comment rules and procedures.

REENTRY FOR PERSONS FORMERLY INCARCERATED

Monitor and participate in, as appropriate, implementation of recommendations in the Reentry Report.

SEXUAL HARASSMENT

Work with SOCR to examine how current sexual harassment policies and practices impact people experiencing sexual harassment. Items to address include, but are not limited to, an Employee Climate Survey, a Human Resource Division Director Survey, and exploring innovations in sexual harassment trainings.

STRUCTURE AND FUNCTION

Monitor the Racial Equity Toolkit (RET) process and the consultant assisting with it regarding the structure and function of SOCR within the Executive branch, and draft potential legislation to implement recommendations from the RET.

ZERO DETENTION

Monitor Zero Detention projects.

ECONOMIC DEVELOPMENT

2026 FIFA SOCCER WORLD CUP

Per Resolutions 31791 and 30340, review information provided regarding the City's potential bid for the 2026 Fédération Internationale de Football Association (FIFA) Soccer World Cup. The information provided shall include: the City's role in the event; estimated event costs; the potential financial exposure to Seattle of the event; proposed agreements with event organizers for reimbursement of security or other costs; expected educational, cultural, economic benefits to Seattle; and proposed financial/legal guarantees.

BUSINESS IMPROVEMENT AREA (BIA) FORMATION AND MODIFICATION

Review and consider proposed legislation for new or revised BIAs.

CITY CONTRACTING POLICIES AND PRACTICES

Review City contracting policies and practices, including requirements and technical assistance for women and minority owned enterprises, priority hiring, etc.

COMMERCIAL AFFORDABILITY

Monitor implementation of the Mayor's Commercial Affordability recommendations, including the Office of Economic Development's (OED) plans to improve King Street Station, and the efforts of the Mayor's Small Business Advisory Council.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FLOAT LOANS AND SECTION 108 LOANS

Review and consider approval of proposed Section 108 loans and possible CDBG float loans. Monitor the Section 108 loan pool via quarterly and annual reports; and review recommendations, if any, to strengthen Section 108 policies.

EFFORTS TO CORRECT ECONOMIC DISPARITIES

Monitor City efforts to identify effective approaches to asset building; job training in key sectors such as technology, restaurants, biotech, and life sciences; access to banking and other financial services; educational attainment; family support; access to health care, healthy foods, and other ways to address historic trends in disparities.

FILM AND MEDIA PRODUCTION CENTER

Monitor implementation of funding for supporting advancement of the film and media production center in Seattle.

LEGACY BUSINESSES

Monitor the design and implementation of (1) a community-based Legacy Business Designation Program and distribution of resources to support legacy businesses; and (2) work with existing Community Development Funds to support business assistance for eligible Legacy Businesses.

MAJOR EVENTS

Review implementation of Resolution 30340 for major events in Seattle.

NEIGHBORHOOD BUSINESS DISTRICT SUPPORT

Monitor the Only in Seattle program.

NEW MARKETS TAX CREDIT (NMTC) PROGRAM AND OTHER LENDING PROGRAMS

Participate in the committee that makes decisions regarding allocation of previously collected NMTC fees.
Review annual report on the NMTC program.

OFFICE OF FILM AND MUSIC

Review and monitor economic development-related legislation including but not limited to City nightlife ordinances, talent and job development initiatives, and business capacity in neighborhood districts.

SHOWBOX THEATER

Review legislation relating to preservation of the Showbox Theater.

SMALL BUSINESS ADVISORY TASK FORCE

Review recommendations of the Small Business Advisory Task Force and implementation of Executive Order 2018-06 (Support for Seattle's Small Businesses), specifically: a) the study of taxes and fees that apply to small businesses in Seattle; b) the feasibility of establishing a program to connect small businesses to trained Seattle youth seeking employment and adults seeking career development and retraining programs; and c) the re-establishment of the Citywide Business Advocacy Team (CBAT) to help Seattle small businesses navigate government. Take legislative action as needed.

SMALL BUSINESS SUPPORT

Monitor the progress of the (1) organization(s) receiving funding to provide technical assistance to the small business community; and (2) organization(s) receiving funding to provide community based economic development programs that are focused on businesses in the Central Area, the Chinatown-International District, and other areas identified as being at high risk of displacement. This includes monitoring the work of supporting minority businesses and communities with technical assistance, marketing programs, micro-financial assistance, and advocacy. Monitor impacts on small businesses affected by City construction projects.

WORKFORCE DEVELOPMENT AND HIGHER EDUCATION POLICIES AND INVESTMENTS

Review OED's ongoing policy and programmatic work in workforce development, including recommendations made by the Workforce Development Council of Seattle and King County. Advocate for provision of financial empowerment services for those accessing training/educational services. Continue to support development of a higher education/skill/entrepreneurial training center in Southeast Seattle. Monitor the Youth Employment Initiative, Green Pathways fellowship program, and Employee Pathways/Green Jobs and consider implementation of recommendations.

EXTERNAL COMMITTEES AND BOARDS AND COMMISSIONS OVERSIGHT ASSIGNMENTS

BOARDS AND COMMISSIONS - OVERSIGHT AND/OR APPOINTMENT AUTHORITY

Monitor and consider commission recommendations and make recommendations on appointments as needed for the Seattle Arts Commission; Seattle Commission for People with Disabilities; Seattle Human Rights Commission; Seattle Investment Fund LLC-Advisory Board; Seattle Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ) Commission; Seattle Women's Commission; Special Events Committee; and Museum Development Authority.

EXTERNAL COMMITTEES - COUNCIL PARTICIPATION

Participate as a member of the following external committees: King County Regional Transit Committee, King County Regional Water Quality Committee, King County Flood Control District Advisory Committee, Economic Development District (EDD), Economic Development Council, Water Resource Inventory Area (WRIA) 9: Green Duwamish, Investment Committee for the New Market Tax Credits Program, Labor-Management Leadership Committee.

GENERAL SUPPORT AND OTHER ISSUES

COMMITTEE COORDINATOR

Coordination of committee's work program.

DEPARTMENT HEAD APPOINTMENTS OR REAPPOINTMENTS

Review qualifications of the individual(s) nominated by the Mayor. Confirm the appointment, if appropriate.

UTILITIES - SPU DRAINAGE AND WASTEWATER

DRAINAGE AND WASTEWATER FUND ISSUES

Address Seattle Public Utilities (SPU) Drainage and Wastewater Fund issues including combined sewer overflow program, stormwater code update, green stormwater infrastructure, utility purchase of service related to transportation and other City functions, capital program implementation, grant acceptance, land transactions, and state and federal stormwater requirements.

SUPERFUND

Continue to monitor efforts to assess and manage potential liabilities and clean-up activities at several sites in the city, including the Duwamish River. Monitor City negotiations with Puget Sound Energy and other potentially liable parties relating to responsibility for clean-up of Gas Work Parks including methods to be used for compliance with the state Model Toxics Control Act.

UTILITIES - SPU SOLID WASTE

CLEAN CITY PROGRAMS

Review and monitor the implementation of the Clean City Programs, including: the Encampment Trash Collection program, the Litter Abatement program, the Sharps Collection program, and the Recreational Vehicle Remediation Pilot program.

COLLECTION OBLIGATIONS

Monitor garbage, recycling, and compost collection, including obligations to Business Improvement Areas, and code updates to collocate all streams of waste.

ELECTRIC FLEET

Per the Committee's September 12, 2017 letter regarding the collections contract, the Committee will monitor and review progress on the development of an electric fleet pilot program.

SOLID WASTE FUND ISSUES

Address Solid Waste Fund issues including contract renewals, capital improvement implementation, rates and rate design proposals, and bond sales.

UTILITIES - SPU WATER

WATER FUND ISSUES

Address Water Fund issues including regional water management relations, rates and rate design proposals, easements, grant agreements, revenue stabilization subfund report review, water system plan updates, Cedar River Habitat Conservation Plan implementation, bond sales, and sale of surplus property, such as unneeded reservoir sites.

AFFORDABILITY AND RESILIENCY REPORTS

Review SPU's Affordability and Accountability Strategic Plan, focused on managing future rate increases and corporate performance, and the Risk and Resiliency Assessment, focused on potential impacts and disruptions to SPU's business. Both of these reports were requested in the 2018-2023 Strategic Business Plan. The Council additionally requested, in SLI 40-1-B-1-2019, that SPU work with Seattle City Light to incorporate an analysis of the Utility Discount Program into the Affordability and Accountability Strategic Plan.

CALL CENTER

Review and monitor the performance of the SPU call center, including customer wait times. The Committee will investigate and identify potential problem areas such as staffing availability and training, and coordinate with Council and SPU on possible ways to resolve the issue.

EMPLOYEE TO MANAGER RATIO

Monitor SPU's progress on improving operational efficiency, including activities related to recommendations from the 2009 State Auditor's report analyzing SPU's managerial practices.

GREEN STORMWATER INFRASTRUCTURE

Monitor expansion of green stormwater infrastructure.

SHIP CANAL WATER QUALITY PROJECT

Review and monitor the development and construction of the Ship Canal Water Quality Project; a joint Seattle / King County underground storage tunnel, which will hold polluted water from Ballard, Fremont, Wallingford, and north Queen Anne, helping to prevent it from overflowing into the Lake Washington Ship Canal. Consider legislation to lift the budget proviso relating to construction of the tunnel portion of the project, as specified in GS 16-1-A-1-2018.

SPU-WIDE ISSUES

2018 Budget Action 38-1-A-1 (Green Sheet): Monitor implementation of the Special Task Force of South Park residents regarding recommendations on the public safety and vitality of that neighborhood.

Continue to monitor implementation of the Chinatown / International District public safety task force recommendations,

SPD 911 RESPONSE TIMES

Monitor issues associated with ongoing 911 response time analysis by SPD, including hearing from SPD on Domestic Violence disparities and staffing and deployment implications for both 911 operators and SPD patrol.

Analyze monthly data reports and examine the quarterly reports that provide a descriptive analysis of the monthly data. Review summary of recruitment activities over the prior quarter; the planned recruitment activity for the near term (e.g., 6-12 months); and summaries of the information captured in the completed separations surveys.

SPECIAL EVENTS

Budget Action 38-3-A-1 (Statement of Legislative Intent): Monitor and participate on Special Events IDT. DISTRICT 2

BEACON HILL TOWN CENTER SAFETY PLANNING

Monitor and review the Seattle Department of Transportation's (SDOT) multi-modal transportation study for North Beacon Hill, including a comprehensive traffic analysis and street-level design concepts for Beacon Avenue.

CHINATOWN / INTERNATIONAL DISTRICT BUSINESS IMPROVEMENT AREA (BIA)

Monitor and review legislation modifying the Chinatown / International District BIA.

DISTRICT 2 LAND USE AND ZONING

Review potential proposed changes to the urban village boundaries around the light rail stations in Southeast Seattle that would expand the area where development could occur. Changes are being considered for all of the villages (North Beacon Hill, North Rainier, Columbia City, Othello and Rainier Beach). Review the rezone contemplated for the Rainier Beach urban village, centered on the light rail station. Legislative review and action would occur in the Select Committee on Mandatory Housing Affordability.

GEORGETOWN TO SOUTH PARK TRAIL PROJECT

Monitor and review project. The project would create a walkable, bikeable path uniting the Georgetown and South Park neighborhoods. The path would enhance walkability between Georgetown and South Park's historic "Main Streets" and connect the heart of the Duwamish Valley.

MOUNT BAKER TOWN CENTER

Monitor and review project. This project will implement pedestrian and bicycle safety improvements identified in the Accessible Mt. Baker plan and also concerns the town center near the Mount Baker light rail station in the North Rainier Valley.

OTHELLO SQUARE (FORMERLY KNOWN AS THE SOUTHEAST SEATTLE ECONOMIC OPPORTUNITY CENTER)

Monitor development of the Southeast Seattle Economic Opportunity Center, now known as Othello Square. Othello Square is a community-led project that will increase access to economic opportunity for multicultural communities in southeast Seattle. Othello square will be a culturally relevant and welcoming place where people in southeast Seattle and beyond can access opportunities for higher education, good paying jobs, and support to start and keep a business. Integrating shared space for cultural organizations and workforce housing will help stabilize communities at risk of displacement and engage diverse residents.

RAINIER AVENUE ROAD SAFETY CORRIDOR PROJECT

Monitor and review SDOT's multimodal study of the Rainier Avenue South corridor and the associated Road Safety Corridor project. Continue working with the community and SDOT on improving the safety of Rainier Avenue South.

REDEVELOPMENT PLAN FOR GOODWILL INDUSTRIES SITE

Monitor and review the redevelopment plan for the Goodwill Industries site. Goodwill Industries, the Seattle Chinatown International District Preservation and Development Authority, Capitol Hill Housing, and Lake Union Partners are collaborating on a feasibility study and set of master development scenarios for the redevelopment of the Goodwill property located at 1400 South Lane Street. The Goodwill site, encompasses almost eight acres and is located at the southeast corner of Little Saigon. Goodwill's vision for the redevelopment includes the addition of both market rate and affordable housing and other uses consistent with Goodwill's mission, community priorities, and a requirement to generate funds to support the redevelopment.

Monitor and review any proposals related to designation of census tracts in District 2 as Opportunity Zones under the federal Tax Cut and Jobs Act of 2017.

EQUITY

CRIMINAL LEGAL SYSTEM REFORM

Monitor and participate in work by the Office for Civil Rights and the Council to create a strategic plan for realigning the City's criminal legal system.

EQUITABLE DEVELOPMENT IMPLEMENTATION PROJECTS

Monitor the development of capital projects in the Equitable Development Implementation Plan, including the following community-sponsored projects: 1) Rainier Beach Food Innovation District; 2) Multicultural Community Center; 3) Othello Square; 4) William Grose Center for Cultural Innovation; and 5) Little Saigon Landmark Project. Legislative review and action would occur in the Human Services, Equitable Development, and Renters' Rights Committee.

EQUITABLE POLICIES IN EDUCATION AND ACHIEVEMENT

In coordination with the GESCNA Committee, review the proposed FEPP implementation plan and implementation steps for the Seattle Promise program.

EQUITY CONTRACTING

Work with Women and Minority Owned Business (WMBE) organizations to develop models and processes that assist them explore opportunities with the City of Seattle, State of Washington, University of Washington and other jurisdictions, and allow the City of Seattle to leverage its expertise with other jurisdictions to assist local WMBE organizations.

FACILITATE RE-ENTRY SOLUTIONS AND COORDINATE WITH KING COUNTY

The 2019 budget includes \$250,000 to assess and pilot strategies to facilitate reentry and coordinate with King County. Funding will support further analysis and assessment of the region's approach and strategies for reentry, strengthen coordination and collaboration efforts with other criminal justice agencies, and pilot new and innovative strategies to help facilitate reentry for individuals with criminal history.

Explore community alternatives to the criminal justice system and incarceration for youth and adults, including improving strategies for youth rehabilitation, alternatives to youth detention, and alternative housing options to youth incarceration.

Monitor implementation of the Democracy Vouchers program. Consider legislative changes recommended by the Seattle Ethics and Elections Commission.

ETHICS AND ELECTIONS

Monitor and review any proposed regulations or supplemental budget changes related to the Seattle Ethics and Elections Commission.

Review miscellaneous committee legislation.

REVIEW OF COUNCIL RULES

Review and consider amendments to Council Rules and examine Open Public Meetings Act training and compliance.

INTERGOVERNMENTAL - REGIONAL ISSUES

OFFICE OF INTERGOVERNMENTAL RELATIONS

Participate in the development of City priorities for local, regional, tribal, state, and federal governments to develop the partnerships needed to successfully advance common interests.

POTENTIAL ANNEXATIONS

Staff discussions and legislation related to the Duwamish Annexation Area and the North Highline Annexation Area proposals. This includes negotiations with King County and special districts related to service transition.

SISTER CITIES PROGRAM

Review legislation that modifies the status of existing sister city affiliations and the current moratorium on sister cities. Consider the annual review of existing sister cities relationships.

STATE AND FEDERAL LEGISLATIVE AGENDA

Coordinate development of the City's State and Federal legislative agendas.

TECHNOLOGY

BROADBAND, WI-FI INTERNET ACCESS, AND 5G WIRELESS COMMUNICATION NETWORK

Oversee City efforts to promote competition among broadband providers, including options to make greater use of City-owned fiber, and monitor City efforts to provide public Wi-Fi access to disadvantaged and underserved communities. Monitor the Privacy Initiative and the implementation of its policies and principles throughout the City organization. Review and take action on proposed budget or other legislation as needed.

SURVEILLANCE TECHNOLOGIES

Consider 12-17 bills to approve technologies that are currently in use by the City. Each bill will be accompanied by a Surveillance Impact Report that will include community feedback as well as feedback from the newly created Community Surveillance Working Group. Review the Inspector General's Surveillance Usage Review Report as well as the CIO's Equity Impact Assessment.

Review proposed legislation for Technology Matching Fund grant awards.

Monitor and review the City's progress on implementing the Seattle Climate Action Plan, including progress under the Bloomberg American Cities Climate Challenge.

HEALTHY FOODS INITIATIVE

Monitor and review the City's progress on expansion of the Fresh Bucks program to address those in the "food security gap."

TRANSPORTATION - CAPITAL PROJECT OVERSIGHT

MODAL PLAN IMPLEMENTATION

Monitor SDOT delivery of projects in the Pedestrian, Bicycle, Freight, and Transit Master Plans.

MOVE SEATTLE IMPLEMENTATION

Monitor SDOT's delivery of transportation projects for the Move Seattle Levy and the work of the Move Seattle Oversight Committee. Monitor SDOT's spending and program adjustments to meet the commitments of Move Seattle.

SEATTLE SQUEEZE

Monitor SDOT efforts to manage near-term construction impacts (Viaduct Removal, Transit Tunnel Closure) and long-term transportation system functions. If authorized under State Law, review SDOT proposals for automated camera enforcement of "block-the-box" incidents and transit lane violations.

STREETCAR OVERSIGHT

Monitor operations of the First Hill and South Lake Union streetcar lines. Review SDOT's proposal for constructing the Center City Streetcar.

TRANSPORTATION - POLICIES AND PROGRAMS

BICYCLE THEFT

Promote education and coordination of efforts to address bicycle theft in Seattle (see also Gender Equity, Safe Communities, New Americans and Education Committee).

COMMUTE TRIP REDUCTION, TRANSPORTATION DEMAND MANAGEMENT, AND CONGESTION PRICING

Explore options for increasing participation in Commute Trip Reduction (CTR) programs. Monitor SDOT's efforts to study congestion pricing.

EMERGING TRANSPORTATION ISSUES

Monitor emerging technological changes and cultural shifts with implications for the City's transportation network. Potential issues include encouraging vehicle electrification, monitoring performance of private bike sharing companies, and exploring the potential impacts of autonomous vehicles.

PARKING POLICY

Explore parking policy options related to on-street parking, residential parking zones, parking benefit districts, and emerging parking issues.

SEATTLE TRANSPORTATION BENEFIT DISTRICT OVERSIGHT

Monitor SDOT management of Seattle Transportation Benefit District Proposition 1 funding for increased transit service. Consider options for a potential renewal of Proposition 1, to be submitted to voters in 2020.

STREET VACATION PETITIONS AND POLICY

Review street vacation petitions proposed to City Council.

VISION ZERO IMPLEMENTATION

Review SDOT proposals for implementing the Vision Zero safety program. Review safety data collection procedures and after-action follow-up. Improve pedestrian and bicycle safety.

TRANSPORTATION - REGIONAL PROJECTS

ALASKAN WAY TUNNEL/SR-99 OVERSIGHT

Monitor progress on the Washington State Department of Transportation's project to replace the viaduct with a tunnel and new surface street. Monitor tolling-related issues and agreements with the State of Washington regarding responsibilities and funding for this project.

SOUND TRANSIT LIGHT RAIL

Monitor and engage in Sound Transit activities to implement ST2 and ST3 projects in Seattle. Co-host the Sound Transit Elected Leadership Stakeholder Group to make recommendations on the preferred alignment for the West Seattle and Ballard light rail projects.

SR-520 OVERSIGHT

Review legislation and agreements related to the Washington State Department of Transportation's SR-520 project. Monitor final design and construction activities related to the Montlake Lid, Portage Bay Bridge, Delmar Lid, and Montlake Cut crossing.
