1. BILL SUMMARY

Legislation Title: A RESOLUTION endorsing the final report and recommendations of the Regional Affordable Housing Task Force.

Summary and background of the Legislation: In response to the growing housing affordability crisis, the Regional Affordable Housing (RAH) Task Force was created in 2017 to bring elected officials from King County, The City of Seattle, and other cities together with the goal of developing a regional plan to address this crisis. The RAH Task Force sought the input from non-profit agencies, private partners, and other experts and held numerous community meetings to take feedback on the regional plan.

The RAH Task Force concluded its work and issued its final report with recommendations in December of 2018. Many of the RAH Task Force's recommendations mirror the strategies identified and being implemented as part of the City's Housing Affordability and Livability Agenda (HALA) adopted by the City in Resolution 31622 in 2015. The City desires to support King County and other cities in the region in their efforts to implement strategies that will increase the regional supply of much needed affordable housing in the coming years. The Resolution endorses the final report and recommendations of the Regional Affordable Housing Task Force.
