1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to land use and zoning; amending Sections 23.41.010 and 23.41.012 of the Seattle Municipal Code to remove the Ballard Municipal Center Master Plan Area Guidelines and adopt the Ballard Neighborhood Design Guidelines, and delete reference to the Ballard Municipal Center Master Plan Area Guidelines.

Summary and background of the Legislation: The ordinance would adopt the Ballard Neighborhood Design Guidelines to guide future development to reflect the historical character of the Ballard Hub Urban Village, retain and enhance the role and character of the different areas in the Ballard Hub Urban Village that are valued by the community. The guidelines will be used in the design review process for multi-family and commercial development in the neighborhood. The ordinance would also make text amendments to subsection 23.41.012.B to remove language relating to the Ballard Municipal Center Master Plan Area Design Guidelines.

Environmental review under the State Environmental Policy Act (SEPA) was also required for this legislation, and publication of notice of the environmental determination was made in The Daily Journal of Commerce and in the City's Land Use Information Bulletin.

Yes. However, existing parcels within the Ballard Hub Urban Village are already subject to design review.
