1. BILL SUMMARY

1. Legislation Title: AN ORDINANCE relating to land use and zoning; amending Section 23.41.010 of the Seattle Municipal Code to approve the Capitol Hill Neighborhood Design Guidelines, 2019.

2. Summary and background of the Legislation:

The ordinance would amend the Capitol Hill Neighborhood Design Guidelines to guide future development reflecting the changing character of the Capitol Hill Urban Center Village, provide guidance for future development to reinforce and augment the neighborhood's architectural qualities, walkable urban form, historic character and natural features. They also provide guidance for how development can support community goals for ecological sustainability, active transportation, walkable urban form, and resilient public realm.

The current neighborhood design guidelines were initially adopted in 2005 and were revised in 2013 to bring them into alignment with new citywide design guidelines adopted that year.

These neighborhood design guidelines have resulted from community engagement processes that involved a diversity of stakeholder groups. In general, these neighborhood
