Please accept this letter by way of applying to join the Move Seattle Levy Oversight Committee. The Levy facilitates both the bread and butter of our transportation system, and its evolution into the transportation system of tomorrow. The Levy is a bold plan, and a firm commitment to Seattle voters and residents. I'm excited by the prospect of helping provide accountability of Seattle's investment. I bring professional and academic experience pertaining to the technical aspects of project oversight, as well as an understanding of multimodal transportation systems and planning.

Between 2010 and 2013 I managed a multi-jurisdictional transportation funding program in Kitsap County, WA. Through this work I gained skills applicable to the oversight role. I have a solid understanding of the technicalities of capital project delivery, including project phasing; construction timelines; and project readiness. Furthermore, I am familiar with the major funding issues pertaining to advancing large capital projects, such as matching projects to appropriate funding sources; parameters pertaining to federal and state grants; and challenges of project delivery with capital projects that must rely on multiple funding sources. Projects that my program funded included road capacity, bridge replacement, transit (capital, not operating), and active transportation projects.

Studying at the University of Washington for my Masters of Public Administration between 2013 and 2016 I approached training in public finance, policy analysis, and benefit/cost analysis with a transportation-focussed lens. I tailored coursework to hone analytical skills that can be applied toward transportation project delivery. I also took UW classes exploring best practices and policies pertaining to multi-modal transportation and land use planning. These studies helped develop my appreciation for the need to holistically plan and invest in freight, transit and active transportation networks.

Through my current role at Cascade Bicycle Club I've begun to focus more on active transportation project delivery – yet in reality many projects occur in concert with multi-modal capital investment. Through this work I'm familiar with many of the projects within the Move Seattle Levy, including the challenges and opportunities specific to those projects.

As the Move Seattle Levy advances, after a thorough review in 2018, I look forward to the prospect of working alongside you to provide accountability to Seattle residents for this vital investment in our transportation system.
