### **1. BILL SUMMARY**

**Legislation Title**: AN ORDINANCE relating to City emergency purchases of goods and services; emergency consultant contracts; and emergency public works contracting; amending Section 10.02.070 of the Seattle Municipal Code to align with current practices and the procedures in subsections 3.39.020.M and 20.50.090.A and Section 20.60.114.

**Summary**: This ordinance aligns the City's code related to purchasing, consulting, and public works contracting under a civil emergency with current practices and the code on all emergency purchases, consulting contracts, and public work contracts.

The legislation:

- Consolidates the process for emergency purchases of goods and services and expands the ordinance to include emergency consultant contracts and emergency public works contracting as outlined throughout the SMC.
- Simplifies the department documentation process for emergency purchases in a civil emergency, including removing the requirement to use now outdated forms and removing the reference to an employee identification card in this process.
- To align with current practice and policies, removes the requirement to seek authorization for these purchases at the end of the emergency by the City Council.
- Directs the City to conduct competitive solicitation to the extent practicable given the emergency in keeping with the reasonable and necessary cost to accomplish eligible work and in compliance with any applicable city, state, or federal laws and regulations.
