**1. BILL SUMMARY**

**Legislation Title:** A RESOLUTION declaring the City Council’s and the Mayor’s intent to consider strategies to protect trees and increase Seattle’s tree canopy cover.

**Summary and background of the Legislation:** In 2001, the City Council adopted Ordinance 120410, establishing Seattle’s first regulations regarding trees on private property. The City then established a goal of reaching 30 percent canopy cover by 2037 in its 2007 Urban Forest Management Plan. To advance this goal, the Council adopted Ordinance 122919 in 2009, adding additional protections for exceptional trees; limits on tree removal from certain developed lots; and enforcement measures. The 2016 Seattle Tree Canopy Assessment found that the city was at 28 percent tree canopy cover and that the single-family residential land use type contributed the most to the city’s canopy cover (63 percent of the total). In recent years, attempts by the Council to initiate an update to the tree regulations have stalled for a variety of factors. This legislation represents the joint commitment by the Mayor and Council to work on updating tree regulations, with a work plan that will be led by the Seattle Department of Construction and Inspections and supported by the Office of Sustainability and Environment.
