*Notice of Public Comment relating to Resolution 31911

As part of this meeting, the Seattle City Council intends to vote on Resolution No. 31911, entitled, 'A RESOLUTION opposing Washington Initiative Measure 976 ("I-976") and urging Seattle voters to vote "No" on I-976 on the November 5, 2019, general election ballot.'

Title of I-976 is below:

Initiative Measure No. 976 concerns motor vehicle taxes and fees. This measure would repeal, reduce, or remove authority to impose certain vehicle taxes and fees; limit annual motor-vehicle-license fees to \$30, except voter-approved charges; and base vehicle taxes on Kelley Blue Book value.
