Payment of the sum of \$28,621,338.16 on PeopleSoft 9.2 mechanical warrants numbered 4100297355-4100300209 plus manual or cancellation issues for claims, E-Payables 10 of \$106,233.85 on PeopleSoft 9.2 9100005236-9100005289 and Electronic Financial 11 12 Transactions (EFT) in the amount of \$73,521,431.64 are presented for ratification by the City 13 Council per RCW 42.24.180. Section 2. Any act consistent with the authority of this ordinance taken prior to its 14 effective date is hereby ratified and confirmed. 15

Section 3. This ordinance shall take effect and be in force 30 days after its approval by 1 2 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it 3 shall take effect as provided by Seattle Municipal Code Section 1.04.020.
