1. BILL SUMMARY

Legislation Title: A RESOLUTION modifying the March 14, 2020 emergency order relating to residential evictions.

Summary and background of the Legislation: The COVID-19 state of emergency has caused illness, business closures, and loss of income from employment. To provide housing stability to individuals and families and prevent people from falling into homelessness because they cannot afford to pay rent due to COVID-19 and increase the exposure risk, and to help prevent closure of local businesses due to the owners ability to pay rent, this resolution modifies the March 14, 2020 emergency order related to residential evictions by:

- Expanding the moratorium on evictions to include commercial tenancies
- Expanding the time period that the moratorium will be in place from 30 days to 60 days
- Expanding the moratorium to cover all evictions, not just nonpayment of rent, including when a lease has terminated, except for eviction actions that result from tenants behavior that presents a risk to others safety
- Adding in language requesting that the KC Sheriff not enforce any evictions during the moratorium
