1 **CITY OF SEATTLE** 31939 2 RESOLUTION 3 4 A RESOLUTION in support of the bid by The City of Seattle to host the National League of 5 Cities 2025 City Summit conference. 6 7 WHEREAS, the National League of Cities (NLC) is the country's oldest, largest, and most 8 representative organization serving municipal governments, with a mission "to strengthen 9 and promote cities as centers of opportunity, leadership, and governance"; and 10 WHEREAS, The City of Seattle is a longtime and active member of the NLC and supports the 11 goals of the NLC; and 12 WHEREAS, the City Summit is the NLC's annual education, training, and governance 13 conference that is held in a different city every year in November; and 14 WHEREAS, the NLC is seeking bids to host its City Summit in 2025; and 15 WHEREAS, Seattle is a dynamic and lively city, offering some of the nation's top restaurants; 16 famous attractions such as the Space Needle and Pike Place Market; and a vibrant sports, 17 music, and arts scene to entertain and delight attendees and guests of the City Summit; 18 and 19 WHEREAS, Seattle is home to both vibrant small businesses and globally recognized 20 corporations, boasting the University of Washington, the Bill and Melinda Gates 21 Foundation, and other leading research and philanthropic institutions; and 22 WHEREAS, Seattle is one of the fastest growing cities in the United States and is experiencing 23 investments in public amenities and infrastructure, including extension of Sound 24 Transit's Link Light Rail service, expansion of the Washington State Convention Center, 25 and development of a new Waterfront Park to reconnect the city to Elliott Bay; and
