Legislation Title: A RESOLUTION in support of fair, direct, and federal emergency support to reopen and rebuild local American economies; and stating that a fully funded Seattle is essential to economic recovery.

Summary and background of the Legislation: The City of Seattle is facing a \$300 million budget shortfall from the COVID-19 emergency due to the City's expected revenue loss. The City has increased emergency expenditures for rental assistance, grocery vouchers, small business stabilization grants, expanded shelter services, personal protective equipment, and coronavirus testing. This resolution asks Congress to allocate fair and direct federal support to all of America's communities, regardless of population size, with flexible funding to address additional expenses incurred for pandemic emergency response and budgetary shortfalls resulting from pauses in commerce, tourism, and other economic sectors.
