This Council Budget Action (CBA) adds administrative support to the current Health One program in the Seattle Fire Department (SFD) and would add a third Health One unit by July 2021. Specifically, this request:

- 1) Adds \$252,702 and two new FTEs in SFD to staff a third Health One team. The third team should be operational by July 01, 2021.
- 2) Imposes the following proviso on HSD:

"Of the appropriations in the 2021 budget for HSD, \$400,000 is appropriated solely for three social workers and two case managers to provide full-time support the Health One program with case management and administrative support with triage/coordination/referrals. Council requests that the social workers have case management experience serving people with diverse needs, including chronic conditions experienced by older people and individuals with disabilities. Council further requests that one of the social worker positions begin supporting the Health One program by March 31, 2021, while the other two start by July 01, 2021."

This CBA would have the effect of causing 5 HSD staff members to stop working on a current body of work to support the SFD Health One program. Central staff is researching the implications that this action would have on HSD operations.

3) Adds \$85,000 GF in onetime spending to acquire an additional retrofitted vehicle as a third Health One unit.
