Budget Action Description:

This Council Budget Action (CBA) would add \$7,000,000 GF one-time funds to the Human Service Department's (HSD's) 2021 budget to increase the number of tiny home villages, which would include \$3,000,000 for startup funds and \$4,000,000 for operations. Assuming one-time startup costs of \$600,000 and operational costs of \$800,000 for a 40-unit tiny home village, this would create five new

tiny home villages that are supported by the City through a contract with a homelessness services agency. CBA HOM-008-B-001 would add \$2.8 million to expand the number of tiny home villages. The combined budget actions, if both approved, would appropriate \$9.8 million to HSD to expand tiny home villages.

This budget action would also reduce the \$32 million proposed to be added to the City's Emergency Fund in CBA FG-006-A-002 to \$25 million to offset the increase provided to HSD.
