9	WHEREAS, on December 11, 2017, the City Council passed Resolution 31786, which called for
10	the issuance of a combined Request for Proposals (RFP) for the disposition of 800
11	Mercer Street and 620 Avenue North to address neighborhood interests, creating
12	opportunities to take advantage of South Lake Union as a "neighborhood of opportunity";
13	and
14	WHEREAS, on September 16, 2019, the City Council passed Ordinance 125916 to authorize the
15	sale of these properties; and
16	WHEREAS, the 2020 Adopted Budget used a portion of the proceeds from the sale of these
17	properties to establish a Strategic Investment Fund to provide investment in areas that are
18	at high risk of displacement or in areas of low access to opportunity that present unique
19	opportunities for transformational equitable development, and placed a proviso directing
20	the Executive to submit a proposed spending plan for this fund; and
21	WHEREAS, the 2021 Adopted Budget re-established the Strategic Investment fund and placed a
22	proviso directing the Executive to submit a proposed spending plan for this fund in
23	Council Budget Action FG-002-B-002; and
24	WHEREAS, a committee of Black, Indigenous, and People of Color (BIPOC) community
25	leaders and equitable development experts convened in 2019 to propose funding criteria
26	for the Strategic Investment Fund to fund the acquisition of land and real estate in order

4	WHEREAS, the Community Advisory Group was reconvened in 2021 to confirm the purpose of	
5	the fund and to design an RFP and collective decision-making process to allocate funds;	
6	and	
7	WHEREAS, the Office of Planning and Community Development published the RFP in early	
8	June 2021, with materials translated in seven languages, and conducted three information	
9	sessions with over 80 participants and over 30 individual conversations with prospective	
10	applicants; and	
11	WHEREAS, 100 proposals were submitted by community-based organizations, small businesses,	
12	cultural organizations, and tenants facing displacement across the City, representing over	
13	\$300 million in funding requests; and	
14	WHEREAS, the Community Advisory Group has made its final recommendations forming the	
15	proposed spending plan and it is now time to lift the proviso on the funds and to	
16	appropriate them to the relevant departments to carry out the work recommended by the	
17	Advisory Group; NOW, THEREFORE,
