The Council requests that DPD complete the environmental review and make a threshold determination, and attempt to report back to the Planning.

Land Use and Sustainability Committee no later than August 31, 2015.

Section 4412. Severability. The provisions of this ordinance are declared to be separate and severable. The invalidity of any clause, sentence, paragraph, sub-division, section or portion of this ordinance,

or the invalidity of the application thereof to any person or circumstance shall not affect the validity of the remainder of this ordinance, or the validity of its application to other persons or circumstances.
