Section 3. ~~The City will restrict resale of h~~All handguns purchased by the Seattle Police Department (SPD) that are no longer needed by the Seattle Police Department SPD shall be destroyed to only law-enforcement entities authorized to possess firearms by applicable state or federal law, replacing the City's policy that the firearms be sold out of state. SPD shall continue to destroy all surrendered or confiscated firearms that do not have a legal reason for their continued retention.
